HLF CREATED AND HIRED A PART-TIME FOUNDATION AND GRANTS COORDINATOR POSITION TO SUPPORT ITS ADMINISTRATIVE AND GRANTMAKING PROCESSES.

HLF'S BOARD ORGANIZES ITS WORK THROUGH FIVE STANDING COMMITTEES: EXECUTIVE; FINANCE; GOVERNANCE; COMMUNITY ENGAGEMENT; AND LEARNING, EVALUATION, AND ASSESSMENT. THESE COMMITTEES MEET AT LEAST QUARTERLY, DEVELOP ANNUAL PRIORITIES, AND UTILIZE WORK PLANS TO ADDRESS BOARD BUSINESS OUTSIDE OF HLF'S BI-MONTHLY BOARD MEETINGS.

IN JULY 2023, HLF'S FINANCE COMMITTEE REVISED THE INVESTMENT POLICY STATEMENT AND ITS ENVIRONMENTAL, SOCIAL, AND GOVERNANCE (ESG) SCREENING REQUIREMENTS. ADDITIONALLY, THE FINANCE COMMITTEE CONDUCTED A THREE-YEAR REVIEW OF ITS INVESTMENT ADVISOR TO ENSURE CUSTOMER SERVICE AND APPROPRIATE OVERSIGHT.

HLF STAFF CONTINUED WORKING WITH A COMMUNICATIONS CONSULTANT TO INCREASE THE ORGANIZATION'S PRESENCE ON THREE SOCIAL MEDIA PLATFORMS, EMAIL MARKETING, AND WEBSITE MARKETING. HLF UTILIZED THESE COMMUNICATIONS MODALITIES TO INCREASE AWARENESS IN THE COMMUNITY AND AMONG AREA NON-PROFITS OF ITS GRANTMAKING AND PROGRAMMING OPPORTUNITIES.
