ATTENDEES PARTICIPATED IN FACILITATED DISCUSSIONS ABOUT THE CHALLENGES FACING HUMAN SERVICES ORGANIZATIONS AND HOW COLLABORATION CAN STRENGTHEN OUR COMMUNITY'S SAFETY NET.
